### Zoning Board of Appeals Official Minutes February 8, 2023 Monmouth City Hall

Chairman Noel called the Zoning Board of Appeals to order at 5:30 p.m., in the City Council Chambers. A roll call was performed. Chairman Noel motioned to approve the minutes from the last meeting which was held on May 11, 2022. The motion was approved by the board.

#### **First Request:**

A special use permit to install ground mounted solar array on 1 of 2 lots, each lot is 1.52-acre strip of ground owned by the Y.M.C.A. of Warren County, and lot in question is adjacent to the main parcel #09-044-084-00 owned by the Y.M.C.A. of Warren County.

Applicant Greg Swanson with Renewable Energy Evolution was present. He explained the installation of the solar array on the lot will establish a 95% electricity offset. Chairman Noel added that there will be a 10ft fence around solar array for safety purposes. Noel went on to ask if there is a building that a battery would be housed in. Greg Swanson stated that there would be no battery storage and that they would bore underground and have no above ground wires. Mr. Swanson further explained that no energy would be stored. The Y.M.C.A would use the electricity needed and then it would go back onto the grid. Board member Uddin asked what would happen if the Y.M.C.A. loses power. Swanson said the solar panels will not act as backup power in the event of an outage. Uddin went on to ask if the seven panels will be adjustable or fixed. Mr. Swanson stated that the panels will be fixed. Noel asked if this project will be a long process to which Swanson responded that the anticipation is for the project to take one month to complete. Swanson went on to say that Renewable Energy Evolution has worked with the Y.M.C.A. in Canton and other facilities on the same type of project. Board member Uddin inquired about the interference with sports being played behind the Y.M.C.A. Sam Brooks explained that the solar array will be located on a baseball field that is no longer in use and will not interfere with any activities.

A motion was made by Uddin and seconded by Rankin. Motion was carried.
