

# Monmouth Fire Department September Monthly Report

## **Emergency Responses:**

The Monmouth Fire Department utilizes fire reporting software approved by the United States Fire Administration and the Office of the Illinois State Fire Marshal. This software records fire department responses in over 90 categories to track fire department emergency response statistics. This information is used by the department to support decision-making for fire response planning. Tracking response data with approved software is also required for fire departments receiving Federal and State grant dollars.

### **Staff Training:**

In September, the MFD staff completed over 230 hours of training including the topics of electrical safety, fire dynamics, donning and doffing an air pack, filling an air cylinder, and specialized maneuvers for navigating confined spaces and entanglement situations. The staff also completed emergency medical training on the topics of pediatric assessment and pediatric seizures.

Firefighters Kyle Martin and Tim LaFollette began attending the Illinois Fire Service Institute's Basic Firefighter/NFPA Firefighter I Academy. Firefighters Martin and LaFollette will complete the 7-weed academy on October 27<sup>th</sup>. The week following the academy, the firefighters will complete a series of classes needed to attain their firefighter certification in Illinois including Fire Service Vehicle Operator, National Incident Management Systems, Courage to be Safe, and CPR. The firefighters will finish up their initial training at IFSI by attending Vehicle Machinery Operations and Hazardous Materials Operations with each class being a week long.

Firefighter Osborn attended Rescue Task Force training that was hosted by the ILETSB (Illinois Law Enforcement Training and Standards Board) Executive Institute at Western Illinois University. The training was held at the West Prairie High School in Sciota where police officers and firefighters trained on how to operate as a Rescue Task Force in active threat situations. The training not only prepared them for how to respond but they are now certified to teach other police and firefighters how to operate as part of a Rescue Task Force. MFD has recently participated in active threat training with the Warren County Sheriff's Department and plans to continue with the training to improve MFD's response to these types of threats.
