ORDINANCE NO. <u>17-036</u>

AN ORDINANCE abating the tax heretofore levied for the year 2017 to pay debt service on \$5,000,000.00 General Obligation Bonds, Series 2007 (Ordinance No. 06-048), of the City of Monmouth, Warren County, Illinois.

WHEREAS, the City Council (the "Council") of the City of Monmouth, Warren County, Illinois (the "City"), by ordinance adopted on the 18th day of December, 2006 (the "Ordinance"), did provide for the issue of \$5,000,000.00 General Obligation Bonds, Series 2007, (the "Bonds"), and the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

WHEREAS, the City has Pledged Revenues (as defined in the Ordinance) available for the purpose of paying debt service on the Bonds heretofore imposed by the 2017 levy; and

WHEREAS, such Pledged Revenues are hereby directed to be deposited into the Bond Fund (as defined in the Ordinance) and used for the purpose of paying debt service on the Bonds; and

WHEREAS, it is necessary and in the best interests of the City that the tax heretofore levied for the year 2017 to pay the Bonds be abated.

NOW THEREFORE, Be It and It is Hereby Ordained by the City Council of the City of Monmouth, Warren County, Illinois, as follows:

- Section 1. Abatement of Tax. The tax heretofore levied for the year 2017 in the Ordinance is hereby abated in its entirety.
- Section 2. Filing of Ordinance. Forthwith upon the adoption of this Ordinance, the City Clerk shall file a certified copy hereof with the County Clerk of Warren County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2017 in accordance with the provisions hereof.

Section 3. Effective Date. This Ordinance shall be in full force and effective
