## **ORDINANCE NO. 20-036**

AN ORDINANCE partially abating the tax heretofore levied for the year 2020 to pay debt service on \$4,200,000.00 General Obligation Refunding Bonds, Series 2020 (Ordinance No. 20-026), of the City of Monmouth, Warren County, Illinois.

WHEREAS, the City Council (the "Council") of the City of Monmouth, Warren County, Illinois (the "City"), by ordinance adopted on the 8<sup>th</sup> day of September, 2020 (the "Ordinance"), did provide for the issue of \$4,200,000.00 General Obligation Refunding Bonds, Series 2020, (the "Bonds"), and the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

WHEREAS, the City has Pledged Revenues (as defined in the Ordinance) available for the purpose of paying debt service on the Bonds heretofore imposed by the 2020 levy; and

WHEREAS, such Pledged Revenues are hereby directed to be deposited into the Bond Fund (as defined in the Ordinance) and used for the purpose of paying debt service on the Bonds; and

WHEREAS, it is necessary and in the best interests of the City that the tax heretofore levied for the year 2020 to pay the Bonds be partially abated.

NOW THEREFORE, Be It and It is Hereby Ordained by the City Council of the City of Monmouth, Warren County, Illinois, as follows:

- Section 1. Abatement of Tax. The tax heretofore levied for the year 2020 in the Ordinance is hereby abated in the amount \$137,775.00 resulting in an extension of \$400,000.00.
- Section 2. Filing of Ordinance. Forthwith upon the adoption of this Ordinance, the City Clerk shall file a certified copy hereof with the County Clerk of Warren County, Illinois, and it shall be the duty of said County Clerk to partially abate said tax levied for the year 2020 in accordance with the provisions hereof.

Section 3. Effective Date	. This Ordinance shall be in full force and effect
