ORDINANCE NO. 20-001

AN ORDINANCE GRANTING A CHANGE OF ZONING

WHEREAS, the Plan Commission for the City of Monmouth met consider the rezoning of the following property from B-2 (Neighborhood Commercial) to R-3 (High Density Residential);

WHEREAS, the Plan Commission held a public meeting on January 2, 2020, that was originally set for December 23, 2019, but was adjourned until January 2, 2020 to establish a quorum, after due public notice, in the manner provided by law was given;

WHEREAS, the Plan Commission listened to the request and gathered the necessary facts and gave those in attendance at said meeting an opportunity to be heard and/or question the entity requesting the change;

WHERES, the Plan Commission has determined it is in the City of Monmouth's best interest to grant a change in zoning from B-2 to R-3 for the real estate described below;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF MONMOUTH, ILLINOIS, as follows:

Section 1:

It is in the best interest of the City of Monmouth that the following property, be Rezoned from B-2 (Neighborhood Commercial) to R-3 (High Density Residential), to wit:
