

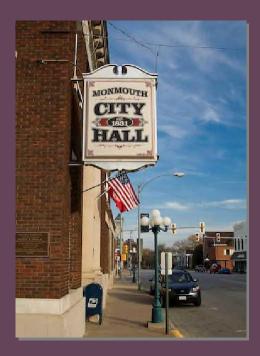

## 1. WASTEWATER TREATMENT

The Consolidated WWTP treated and discharged 119 million gallons of wastewater in the month of March. There was 1 combined sewer overflow event in March. The weather station at the plant reported 3.2" of rainfall and 4" of snow during the month. The Consolidated Plant continues to produce excellent effluent quality. The table below outlines the water quality vs. NPDES permit limits.

#### A SUMMARY OF MAINTENANCE & REPAIR ACTIVITIES:

#### Water/Street Facilities

Maintenance staff completed 63 preventatives and 19 corrective work orders for the water plants, distribution system, and fleet in March. 87 requests for service were responded to by service personnel. 110 requests for City utility locates from the J.U.L.I.E. call center were completed.

Water distribution system and sewer collection system items:

- Replaced 12 water meters
- Repaired water main 300 block North 9th
- Repaired water service 502 East Franklin
- Repaired water service 222 South 6th
- Rebuilt storm sewer manhole at North A and West Detroit
- Replaced 80 feet of 18" storm sewer, new tub, and 3 connections in the 700 block of North 11th



- Replaced 100' of 12" PVC drain culvert at Citizens Lake
- Installed 8 concrete bollard posts in the 400 block of West 6<sup>th</sup> Avenue (across from Wells Pet Food) along the right of way to protect the boulevard from wheel rutting
- Installed 100' of 4" drain tile and intake tub along the south right of way in the 1000 block of West Boston
- Replaced check valve and injector body on chlorine booster pump at North Water Plant
- Replaced 5feet of brine piping at North Water Plant

#### Wastewater Facilities

Maintenance staff performed 87 preventatives and 3 corrective work orders at the Consolidated Plant, and, 38 preventatives work orders and 2 corrective work order at the Pre-Treatment plant.

- Electric Pump replaced seals and coolant on raw wastewater pump #4 under warranty work
- Installed 3 new bulbs on the pole lights at the WWTP
- C&D Electric tuned the add-a-phase apparatus at Parkway Manor Lift Station
- Replaced diaphragm on Sodium Aluminate chemical feed pump #1
- Installed blower motor #4 to blower #5 blower motor #5 suffered bearing failure

#### Street/Grounds/Right of Way/Fleet

- Various tree removal and trimming
- Scheduled vehicle service work (lube, oil, filters)
- Street sweeping
- Patching
- Replaced quick connect pin on the Komatzu endloader
- Replaced rear brakes, bearings, and rotors on T18
- Replaced drive sprocket, chain, upper and lower belt bearings on the Street Sweeper
- Replaced tire on T5

# 7. CAPITAL PROJECTS

Well 10 – awaiting C2 permit, received raw water main construction permit from the Illinois Environmental Protection Agency, contractor is looking at options for installation so as not to risk any excavation issue at the cemetery.

CSO Phase 1 - contractor, (Leander) has secured their bonds and insurance per the contract documents, signatures and notice to proceed have been issued to Leander. Anticipate construction will commence once the weather straightens up.

North WWTP Design – engineering group working on the clarifier design and bio gas feasibility with several deliverables due in June.
