

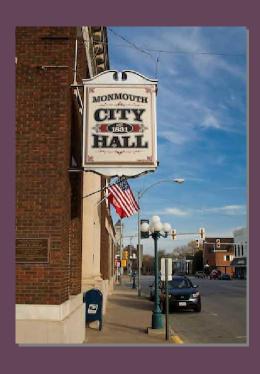

## 1. WASTEWATER TREATMENT

The Consolidated WWTP treated and discharged 87 million gallons of wastewater in the month of August. There were no combined sewer overflow events in August. The weather station at the plant reported 2.1" of rainfall during the month. The Consolidated Plant continues to produce excellent effluent quality. The table below outlines the water quality vs. NPDES permit limits.

The water treatment plants produced 85 million gallons of finished water in August. Finished water quality met all standards per the Clean Water Act for drinking water. The table below outlines the chemical usage for ion exchange softening for the month.

#### A SUMMARY OF MAINTENANCE & REPAIR ACTIVITIES:

#### **Water/Street Facilities**

Maintenance staff completed 46 preventatives and 18 corrective work orders for the water plants, distribution system, and fleet in August. 115 requests for service were responded to by service personnel. 282 requests for City utility locates from the J.U.L.I.E. call center were completed.

Water distribution system and sewer collection system items:

- Replaced 7 water meters
- Repaired water main 500 block East Clinton
- Repaired water main 700 block South 2nd
- Repaired curb stop 615 East 4th
- Repaired curb stop 1118 East 5th
- Repaired curb stop 908 Sunset Road



- Cleaned sewer 400 block North E
- Cleaned sewer 100 block North 6th

#### **Wastewater Facilities**

Maintenance staff performed 78 preventatives and 4 corrective work orders at the Consolidated Plant, and, 37 preventatives work orders and 2 corrective work order at the Pre-Treatment plant.

- Installed new HOMA pump in Parkway Manor lift station
- Installed new float bracket on East 2<sup>nd</sup> Avenue lift station
- Installed new pump in Industrial Park lift station
- Installed new holding brackets on equipment trailer
- Installed new seal on Sodium Aluminate chemical feed pump at GEMS unit
- Installed and aligned rebuilt electric motor on blower #5 at pre-treatment plant from lightning strike

### Street/Grounds/Right of Way/Fleet

- Various tree removal and trimming
- Scheduled vehicle service work (lube, oil, filters)
- Street sweeping
- Patching
- Replaced fuse holder T17
- Replaced brake pads T4
- Replaced transmission cooler hose T19
- Replaced tire tubes on batwing mower
